On the CUSP: Stop BSI is a national initiative to implement a proven culture change model, the Comprehensive Unit-based Safety Program (CUSP) and interventions to prevent blood stream infections (BSI). The initiative has worked to improve safety culture and reduce the mean rate of BSI in hospital units participating in the program to less than one per 1,000 central line days.

The New Jersey Hospital Association, Quality Insights Renal Network 3 and the New Jersey Learning and Action Network have partnered to develop a plan that will sustain the effort to eliminate BSIs in New Jersey healthcare settings. The initiative aims to introduce dialysis units to this program of educating and deploying the CUSP methodology; and to implement evidenced-based interventions/strategies to reduce or eliminate BSI and vascular access (VA) infections for end stage renal disease (ESRD) patients.

This is the second face-to-face meeting for Cohort 1 that has been working collaboratively since January to reduce infections in New Jersey dialysis patients.

At the conclusion of this activity, participants should be able to:

- Define and discuss the concepts of Comprehensive Unit-based Safety Programs (CUSP)
- Identify evidence-based strategies aimed at reducing BSI for ESRD patients
- Understand an organizational culture that supports CUSP awareness through improved communication and structural elements
- Identify and analyze strategies to enhance teamwork and communication.
