Overview:

Regardless of the care setting, the fragile nature of an elderly individual significantly increase the risk for falls or falls with serious injury or disability. Individuals moving from one level of care to another experience changes in level of need based on diagnoses, co-morbid conditions, response to treatment or the natural changes related to the aging process. Providers are faces with the challenge of deigning effective risk assessment mechanism, establishing follow-up protocols, implementing policies and practices, and educating staff, patients and residents in a way that meet the needs of the communities they serve.

This full day workshop led by Patricia Dykes, Ph.D, RN, RAAN, FACMI, Associate Professor of Medicine, Harvard Medical School, Sr. Nurse Scientist Program Director, Nursing Research, Center for Nursing Excellence at Brigham and Women’s Hospital and her team will provide hands-on education around falls prevention and a step-by-step implementation plan for Dr. Dykes’s evidence-based TIPS program. Teams that attend the workshop will enter into the NJ TIPS Collaborative led by Dr. Dykes which will include monthly calls to report on progress including adherence data (process measures) and outcomes (patient falls/injuries) with ongoing support to overcome challenges, review and revise tools. The Collaborative will also have the chance to report out and publish their results.

Topics for the conference will include:

1. Falls knowledge pre-test, assessment and gap analyses
2. In-depth education into the Fall TIPS Program
3. Overview of evaluation and measurement, including process and outcome measures

Participant Outcome:

Participants will have a comprehensive understanding of assessing for fall risk and of how to design a patient-specific fall prevention program that reduce risk, prevents fall and fall-related injury. Participants are also expected to participate in the NJHA Fall TIPS Collaborative that will begin in May 2017.
