#### PROGRAM OBJECTIVES

This course focuses on I'm Still HereTM: Hearthstone's Montessori-Based Activity Program (MAP), an innovative method of working with persons living with cognitive impairments based on the educational philosophies of famed childhood educator Maria Montessori. methodology has been researched for over 15 years by Dr. Cameron Camp and has been shown to significantly increase levels of engagement, participation, satisfaction, success and quality of life for persons living with dementia. Participants in this course will learn the fundamental principles of this methodology, in addition to the application of these principles using real-life examples drawn from their use at Hearthstone's treatment residences.

At the conclusion of this activity, participants should be able to:

- Describe dementia and how it affects the brain
- List ways that participation in activities may be helpful to a person with dementia
- Assess persons with dementia to determine if they are appropriate for Montessori-based programming
- Cite the basic principles of Montessori-based programming
