PROGRAM SUMMARY

The CCS Exam Preparation is a two-day refresher course designed to assist you with the challenges in studying for AHIMA's Certified Coding Specialist (CCS) Examination. Are you ready? Each program is designed to improve, review, refresh, and renew your coding skills.

Each program, the CPT Review and the ICD-9 Review, will assess test taking skills, offer guidance and practice with multiple choice test taking, and offer advice on what you need to do to prepare for the actual exam.

The methods utilized will include lecture, discussion, multiple choice tests, and exercises. We will target topics most likely to be covered in the CCS exam.

The CPT session on July 13 will cover CPT 101, conventions, the book, body systems, modifiers, reimbursement, and difficult coding topics including skin section, orthopedic sections, and scopes.

The ICD-9-CM session on July 14 will cover guidelines, conventions, outpatient guidelines, the Present on Admission Indicator, and reimbursement issues. Topics will include coding of procedures, neoplasms, pregnancy, diabetes, infectious disease, and cardiac cases.
