Subject: July 1 – September 30, 2017 Mental Health Subsidy Allocation

Attached please find the first quarter SFY 2018 Mental Health Subsidy Fund allocation. The Mental Health Subsidy Fund is calculated on a quarterly basis to reflect changes in the number of STCF and CCIS beds recognized at each hospital. This schedule shows the total payments by hospital for the three-month period ending September 30, 2017. To determine your monthly payments for the quarter, divide the amount listed for your hospital by three. Also included is a comparison to the previous quarter's allocation.

The Mental Health Subsidy Fund allocates available funds based on the number of Short Term Care Facility (STCF) and Child Community Inpatient Service (CCIS) beds as recognized by the N.J. Division of Mental Health Services. The amount of funds allocated for the first quarter of SFY 2018 is \$6,157,834. Effective July 1, 2017, there are 380 STCF beds and 123 CCIS beds. The N.J. Division of Mental Health Services adjusted the number of STCF beds to reflect the one STCF bed that was put back on line at Raritan Bay Medical Center as of May 3, 2017.

The SFY 2018 Q1 adjustment corrects for that and includes an amount due to the hospital.
