PARTNERSHIP FOR PATIENTS-NJHIIN UPDATES

The New Jersey Hospital Improvement Innovation Network (NJHIIN) is recruiting hospitals to join the national collaborative "States Targeting Reduction in Infections Via Engagement (STRIVE)."

Beginning April 1, this 12-month initiative, led by the American Hospital Association's Health Research and Educational Trust and the Centers for Disease Control and Prevention, is aimed at hospitals working to reduce *C. difficile* and other healthcare-associated infections (HAIs) such as MRSA, CAUTI & CLABSI by improving basic infection prevention practices and implementation of HAI-specific interventions.

The Collaborative's areas of focus will continue on improving the early identification and treatment of sepsis as well as expanding to identify strategies to prevent sepsis-related readmissions and engaging patients and their families in sepsis awareness and prevention.



NJHA will continue to provide hospitals with the quarterly sepsis mortality reports. For consistency, the sepsis process measures collected under this collaborative will align with what hospitals are currently reporting to CMS.
