NJHA is launching a statewide Pressure Injury Prevention Learning and Action Collaborative beginning in May 2017.

Taking the lessons learned and strategies implemented during the 2005 Pressure Ulcer Collaborative, NJHA, under the Hospital Improvement Innovation Network (HIIN), aims to re-energize this great work and identify any remaining gaps in clinical interventions and encourage sharing best practices amongst hospitals.

### SPOTLIGHT ON SAFETY

Saint Peter's University Hospital developed a Pediatric Safe Imaging committee, consisting of ED physicians, ED nurses, a radiologist, a radiology technician, nursing education, pediatricians and quality department staff.

The Pediatric Safe Imaging committee's goal is to reduce the number of unnecessary head CAT scans performed in the pediatric population by following the PECARN guidelines, which is a current practice of our ED physicians. If a head CAT scan is necessary, the goal is to decrease the exposure to ionizing radiation.

The committee will focus on providing education to the physicians and nurses, developing educational pamphlets for parents, drill down on the data to reveal any possible trends and regularly review American College of Radiology (ACR) dose registry data.

### Pat Dimino

Dimino Pat is the coordinator of quality NJHA's projects for Health Research and Educational Trust, since January 2014. She earned her undergraduate business degree from KEAN University and holds a Master's degree Human Resource in

Management from Rutger's University.

Pat's varied responsibilities at NJHA include State Hospital Association lead (SHA) for the AHRQ Safety Program for Long-Term Care: HAIs/CAUTI; which concluded in the fall of 2016. She is currently SHA lead for the AHRQ Safety Program for ICUs: CLABSI/CAUTI Cohorts 1 and 2. In this role, Pat monitors performance data for CLABSI and CAUTI rates, conducts state-level site visits and is the primary contact providing support for ICUs participating in the project.

In addition, Pat is working with the SHA lead for New Jersey for STRIVE (States Targeting Reduction in Infections via Engagement). Funded through the Centers for Disease Control and Prevention, this initiative was launched in April 2017. Hospitals participating in this initiative will benefit from improved coordination of infection prevention efforts and foster strong working relationships with collaborations among state hospital associations, state health departments and CMS Quality Innovation Network/Quality Improvement Organizations.

Prior to coming to NJHA, Pat worked in long-term care for 20 years as a licensed nursing home administrator and certified assisted living administrator in New Jersey.
