HRET's Interpreter Training for Bilingual Staff in Healthcare

NJHA's Health Research and Educational Trust of New Jersey (HRET) offers a one-day, eight-hour training course designed to provide bilingual staff with skills and knowledge needed to properly serve as dual-role interpreters and enhance communication between providers and diverse patient populations.

HRET's Interpreter Training for Bilingual Staff in Healthcare is taught by expert instructors in the fields of medicine, health equity and quality improvement and includes major components from more extensive training models with special emphasis on standards, policies and procedures for interpreter services as well as cultural competency. To date, more than 1,000 bilingual staff from 80 healthcare organizations have been successfully trained.

Effective communication and cultural competency is paramount for achieving high-quality care and patient safety – a standard of care recognized and required by The Joint Commission (TJC). HRET's training program offers a cost-effective alternative for advancing workforce competency and meeting TJC's requirements. HRET's program is the first step in preparing participants and building the number of training hours needed to meet this prerequisite. Eligible participants are able to receive up to 7.0 hours of CMEs.

Robert Wood Johnson University Hospital Somerset –

Opening Doors to PROUD Family Health

Robert Wood Johnson University Hospital Somerset (RWJ Somerset) has become the first hospital in New Jersey to offer specialized primary care services for the LGBTQIA community when the hospital opened PROUD Family Health at the RWJ Somerset Family Practice on Monday, Jan. 30.

PROUD Family Health will provide services tailored to meet the unique health care needs of the LGBTQIA (lesbian, gay, bisexual, transgender, queer, intersex, asexual) community in a safe, supportive environment. Services include primary medical care for children and adults, hormone therapy and monitoring, HIV care, health education, counseling, support groups and referrals for specialty services such as behavioral health services. All employees at RWJ Somerset have undergone LGBTQIA sensitivity training.

RWJUH is nationally recognized for providing culturally competent care and reducing healthcare disparities. The

Last March, RWJ Somerset and The Pride Center of New Jersey launched a Transgender Family Support Group – the first of its kind in the region designed to help spouses, partners and adult children better understand, accept and cope with their transgender family members. In July of last year, the Somerset campus hosted the U.S. Department of Justice's Civil Rights Roundtable focusing on LGBT equality.

On Sun., Jan. 29, RWJ Somerset received The Pride Center of New Jersey's 2016 Community Partnership Award presented for contributions and support to New Jersey's LGBTQIA Community.
