# PARTNERSHIP FOR PATIENTS-NJHIIN UPDATES

NJHIIN and the New Jersey Department of Health (NJDOH) hosted a Targeted Assessment for Prevention Workshop Aug. 4 as part of its Infection Prevention Collaborative, States Targeting Reduction in Infections via Engagement (STRIVE). The Targeted Assessment for Prevention (TAP) Strategy is a framework for quality improvement developed by the Centers for Disease Control and Prevention to use data for action to prevent healthcare-associated infections.



The TAP Strategy consists of three components:

1. Running TAP Reports in the

National Healthcare Safety Network to target healthcare facilities and specific units with an excess burden of HAIs.

2. Administering TAP Facility Assessment Tools to identify gaps in infection prevention in the targeted locations.

3. Accessing infection prevention resources within the TAP Implementation Guide to address those gaps.

This full-day workshop provided participants with education and coaching on how to use the TAP Strategy to enhance infection prevention efforts within the STRIVE program framework. Additionally, hospital teams learned about testing change using the Plan-Do-Study-Act (PDSA) model and, during a fun exercise, used Mr. Potato Heads as a creative way to practice testing change.

STRIVE, under funding from the CDC, is bringing together multiple organizations at the state level to improve coordination of infection prevention efforts and foster strong working relationships. This project is designed to enhance collaboration and alignment among state partners including NJHA and the NJDOH.

# Fall Prevention T.I.P.S. - Tailoring Interventions for Patient Safety

As part of the previous HEN work, several New Jersey hospitals have engaged in the Fall Prevention T.I.P.S. (Tailoring Interventions for Patient Safety) program. The Fall TIPS application is designed to prevent patient falls by translating routine nursing fall risk assessment into a decision support intervention that communicates fall risk status and creates a tailored evidence-based plan of care that is accessible to the care team, patients and family members.

This fall prevention work continues under the HIIN contract. At the NJHIIN Fall Prevention TIPS workshop held in May, teams from 15 hospitals learned about the TIPS Falls Prevention tool and created action plans to take back to their hospitals.

Kennedy Health has embraced the TIPS program and has plans to implement the strategies and best practices through a pilot phase, followed by a system rollout next spring. 
The TIPS program implementation outline for hospitals consists of the following:

- Obtain organizational support

   Leadership and unit director support
- 2. Print, laminate paper Fall TIPS
- Meet with practice committee and unit nurses

   Recruit champions (for peer support/training and maybe data collection)
- 4. Conduct fall risk assessment competency training with all staffa. Using provided training toolkit
- Track progress weekly

   How often is Fall TIPS completed? (within 24 hours of admission and updated at least once a day)
  - b. How accurate and up-to-date is the tool?
  - c. How many days since last fall?
- 6. Provide continuous feedback
  - a. Via email and posters
  - b. In-person rounding on nurses
  - c. Promote patient engagement and education

### NJHA to Host Surgical Safety Conference Sept. 15

Several New Jersey hospitals have enrolled in the *AHRQ Safety Program for Improving Surgical Care and Recovery*, a collaborative program to enhance the recovery of surgical patients. The goal is to improve patient outcomes through helping hospitals implement enhanced recovery after surgery (ERAS) practices by:

- $\rightarrow$  Utilizing evidence;
- $\rightarrow$  Employing change management techniques;
- $\rightarrow$  Reviewing data.

The program incorporates principles and methods from the Comprehensive Unit-based Safety Program (CUSP), a patient safety method that improves safety culture, teamwork and communication to promote use of evidence-based practices.
