PROGRAM OBJECTIVES

This fall will feature hotly contested elections for President and Congress. Gubernatorial and state legislative elections are slated for next year. As the law evolves and the opportunity for political participation increases, hospitals and affiliated entities need to understand the "Dos and Don'ts" of political activity to avoid inadvertent violations of the law.

Hospitals organized as not-for-profit entities are prohibited from participating in state and federal elections, but their officers, trustees and employees may participate in a personal capacity. In addition to direct contributions to candidate and political party committees, participation may be in the form of contributions to political action committees that support candidates. For-profit hospitals (and forprofit affiliates of not-for-profit hospitals), like other corporations, are permitted to make election expenditures pursuant to the Citizens United case. Super PACs are becoming a dominant element of federal election campaigns.

Affiliation with other IRC 501(c) organizations (such as a social welfare organization under IRC 501(c)(4)) also offers a means for engagement with the public on political issues.
