In 2010, the Institute of Medicine issued its report, *The Future of Nursing*, as a result of a twoyear initiative to assess and transform the nursing profession. This initiative, funded by the Robert Wood Johnson Foundation, contained several recommendations. Among the recommendations: "Nurses should be full partners, with physicians and other health care professionals, in redesigning health care in the United States."

Nurses should be ready to assume leadership roles on advisory and governance boards, where policy decisions that impact healthcare are made and where they can impact healthcare reform-related implementation efforts.
