The New Jersey Baby-Friendly<sup>™</sup> Hospital Initiative is a quality improvement program aimed at increasing breastfeeding rates in the state's maternity hospitals. This collaborative hospital program is supported by the generosity of the Chronic Disease Prevention and Control Unit, Division of Family Health, New Jersey Department of Health, through the CDC's DP12-1305 grant "State Public Health Actions to Prevent and Control Diabetes, Heart Disease, Obesity and Associated Risk Factors and Promote School Health".

The mission of the Office of Nutrition and Fitness (ONF) is to lead in coordinating partnerships to continue to support the statewide obesity prevention partnership to effectively implement policy and environmental change to improve healthful eating, physical activity and to prevent and control obesity because of its link to chronic disease.

At the beginning of the work in New Jersey there were no designated Baby-Friendly<sup>TM</sup> hospitals in the state. New Jersey now has four hospitals designated as Baby-Friendly<sup>TM</sup> and over 20 more hospitals are on their pathway to achieving this prestigious designation.

This didactic learning session is intended to continue the "all teach, all learn" collaborative work of the initiative and to expand its successes through the designated hospitals' expertise. The New Jersey Mother Baby summit is designed to assist providers in addressing barriers and identifying potential solutions for implementing the Ten Steps to Successful Breastfeeding and Baby-Friendly<sup>TM</sup> designation.

- 2. State how improvement science is being used to advance improvement in maternity care practices to support exclusive breastfeeding

- 6. Discuss the Perinatal Care core performance measures and list three resources available for improving outcomes

- 8. Identify steps that will assist hospitals in the adaptation of the World Health Organization's Code of Marketing of Breast Milk Substitutes from formula purchasing to administrative support.
