## **PROGRAM OVERVIEW:**

Recently, the Centers for Medicare and Medicaid Services updated interpretive guidelines for long term care settings. Two of the most important updates concern F309 – care of a resident with dementia and F329 – unnecessary medications. This Webinar will focus on the key sections of the interpretive guidelines used by surveyors. In addition, in Oct. 2014 changes were implemented to the MDS 3.0. These include changes to the Resident Assessment Manual and the MDS 3.0 item set. Presenters will review the changes and discuss how they affect your facility's process for managing the MDS 3.0.
