Severe sepsis mortality reaches beyond ICUs and emergency departments (EDs). Based on statewide hospital data, over 6,000 patients with severe sepsis died in New Jersey hospitals in 2013. These deaths account for nearly a 30 percent mortality rate related to severe sepsis across 72 hospitals. The mission of the collaborative and this program is to spread evidence-based sepsis interventions beyond ICUs and EDs to medical-surgical patient populations. This program will focus on severe sepsis interventions designed to address early recognition and rapid treatment of illness.

OBJECTIVES:

1. Discusses the current state of severe sepsis collaborative activities in New Jersey
2. Recognizes the different components of both the three- and six-hour severe sepsis treatment bundles
3. Understands the baseline severe sepsis treatment bundle and mortality data trends for New Jersey hospitals
4. Discusses the recent severe sepsis clinical trials, results and implications for the future of sepsis treatment
5. Plans for ongoing implementation of sepsis best practices within healthcare settings.

FACULTY:

R. PHILLIP DELLINGER, MD, MCCM



Dr. R. Phillip Dellinger is Professor and Chairman of Medicine at Cooper Medical School of Rowan University. He is the Medical Director of the Adult Health Institute and Senior Attending Critical Care, Cooper University Health (CUH). His primary academic interests are new innovative sepsis therapies, sepsis management and sepsis performance improvement. He co-edited the second, third and fourth (2014) edition of the major critical care textbook, *Critical Care Medicine* (Mosby). He is associate editor of *Critical Care Medicine* journal. He was the 15th recipient of the Lifetime Achievement Award in the 45 year history of the Society of Critical Care Medicine (SCCM) at the organization's 2015 annual meeting.

He was inducted as a Master Fellow in the College of Critical Care Medicine in 2012 (one of the first 20 to have been bestowed this designation looking back over 43 years of the SCCM's existence) and is a Past President of the Society of Critical Care Medicine. Dr. Dellinger was an associate chair of the 1992 consensus conference that created the first definitions for sepsis and chaired the 1997 National Institutes of Health (NIH)/American College of Chest Physicians workshop, "The Future of Sepsis Research". He is past chairman of the International Sepsis Forum (ISF), currently serves on the ISF Governing Council and was co-chair of the 2012 ISF Scientific Colloquium on Clinical Trial Design held at the NIH. He serves on the executive committee of the Surviving Sepsis Campaign (SSC). He co-chaired the committee that created the 2004 SSC International Guidelines on the Management of Severe Sepsis and Septic Shock and chaired the first revision of these guidelines in 2008. He was co-chair and lead author of the 2013 SSC guidelines revision, now sponsored by 30 international scientific organizations. He previously served on the Institute for Healthcare Improvement (IHI) ICU Collaborative Advisory Board as well as the Rhode Island and New Jersey Hospital Association ICU Sepsis Performance Improvement Collaborative and currently serves as faculty for the SCCM/Society Hospital Medicine initiative, Sepsis Hospital Floors Performance Improvement Collaborative. He also Co-Chairs content development for the ongoing Maryland Hospital Association and Maryland Patient Safety Center Collaborative for sepsis performance improvement.

CHRISTA SCHORR, RN, MSN, FCCM

Christa Schorr has a clinical and research experience in both cardiology and critical care. Her experience includes employment as a staff nurse, clinical/research nurse, data coordinator and as Director of Databases for Quality Improvement and Research Program Director of Critical Care Clinical Trials. Her involvement in quality facilitated her participation as a co-leader in Cooper's application process leading to selection for the prestigious American College Critical Care Nursing Excellence in Multidisciplinary Collaboration (May 2008) and Beacon Award - ICU & CCU (October 2008).



Ms. Schorr has authored or co-authored over 100 peer reviewed articles, invited book chapters and abstracts primarily in sepsis quality improvement. Working with the Institute for Healthcare Improvement, she was part of the three member team that developed, field tested and finalized the content of the Surviving Sepsis Campaign (SSC) performance improvement(PI) software that has been used by more than 200 sites all over the world to enter over 30,000 patients in the SCCM housed severe sepsis PI database. She was a leader in the development of the SSC software revision to reflect the 2012 guidelines, as well as the nurse leader for the design, implementation and analysis of the SSC PI program and serve on the SSC Guidelines Committee. Ms. Schorr has also served as national faculty for the SCCM SSC ICU East and West Coast Collaborative and two statewide collaboratives (NJ and RI) and currently with Maryland and Connecticut. Currently, she is a member of the leadership in charge of curriculum development for the Severe Sepsis on the Wards quality improvement program.
