OVERVIEW:

Based on statewide hospital data, more than 6,000 patients with severe sepsis died in New Jersey hospitals in 2013. These deaths account for a nearly 30-percent mortality rate related to severe sepsis across 72 hospitals. Severe sepsis mortality reaches beyond ICUs and emergency departments (EDs). The mission of the New Jersey Sepsis Learning-Action collaborative and this face-to-face program is to spread evidence-based sepsis interventions beyond ICUs and EDs to medical-surgical patient populations. This program is the second in the series and will focus on spreading severe sepsis interventions designed to address early recognition and rapid treatment of illness.

OBJECTIVES:

1. Discuss the current state of severe sepsis collaborative activities in New Jersey
2. Recognize the challenges of the 6-hour severe sepsis treatment bundles and strategies to improve compliance
3. Understand the current severe sepsis treatment bundle and mortality data trends for New Jersey hospitals
4. Discuss the difference roles of healthcare workers in a sepsis improvement program
5. Plan for ongoing implementation of sepsis best practices within healthcare settings.
