What Value-Based Purchasing Means to Post-Acute Providers

Thursday, Nov. 12

2 – 3:30 p.m.

Brian Ellsworth and Beth Carlson will address five major trends in value-based purchasing and their implications for post-acute care providers. This presentation will include state-specific information and is designed to motivate increased attention to marketplace changes related to value-based care.

Bundled Payments as a Platform to Understanding Value-Based Purchasing

Friday, Dec. 4

10 – 11:30 a.m.

Brian Ellsworth and Beth Carlson will address the basics of Medicare's bundling initiative and the recently proposed Comprehensive Care for Joint Replacement (CCJR) Model, as well as an example of bundling used by Medicaid programs (e.g., Arkansas). This session will identify roles and opportunities for post-acute and long-term care providers, discuss care redesign, and provide strategies to successfully approach hospitals, physician groups and at-risk payers.

New Models of Care Under Value-Based Purchasing

Monday, Dec. 14

2 – 3:30 p.m.

Brent Feorene and Beth Carlson will address emerging models of care under value-based payment, including greater use of physicians and nurse practitioners in community-based care settings, use of INTERACT and other tools for reduced readmissions, and new approaches to value-based care delivery.

Understanding Risk in a Value-Based World

Tuesday, Jan. 12

2 – 3:30 p.m.

This presentation given by Brian Ellsworth and Tom Stitt will include: a discussion of the latest trends in value-based contracting with managed care plans; a primer for understanding how risk works in value-based arrangements such as bundling and New York's level 1 and 2 shared savings; and an explanation of opportunities/risks for gainsharing with at-risk entities.
