OVERVIEW:

Dating back to the 1930's, New Jersey's multidisciplinary Maternal Mortality Review process, which focuses on systematic service delivery issues as well as professional and consumer education, has been used as a model across the country. With leaders from across the maternal-child health continuum at the table, regular case review provides insight into the social, economic, cultural and health system factors associated with pregnancy-related deaths. The information gleaned from case review is then integrated into quality improvement at the state and local levels.

The Statewide Perinatal Safety Collaborative Spring Learning Session will focus on the work within and extending beyond our region aimed at moving forward change and preventing further harm across the board.

OBJECTIVES:

1. Name three lessons learned from pregnancy-associated deaths that can be transferrable to your organization
2. Identify how a systematic multidisciplinary case to reducing harm across the board can be implemented at the local level
3. Identify two high-risk system issues associated with pregnancy-associated death
4. Relate relevant components of the American Heart Association's scientific statement on maternal resuscitation to local care practice
5. Translate the work of New Jersey case presentations to local hospital initiatives aimed at improving patient safety and outcomes
6. Describe how AIM aligns with national, state and hospital level efforts to improve maternal health and safety.
