## “Will the Healthcare Payment and Delivery Systems Really Change?”

Over the last several years, healthcare providers have been in a difficult position of having to decide on how to restructure the way they provide care towards more bundled and global payment systems while much of the services they provide were still being paid on a fee-for-service basis. Dr. Altman makes the case that recent changes in the way

Medicare and private insurance pays for care has tilted the equation in favor of moving toward the alternative payment systems. This is especially true with respect to the linkage between acute and post-acute care. Providers also will have to recognize that the growth of future revenues will be more constrained, forcing delivery systems to be concerned about the cost of the services they provide.
