PROGRAM OVERVIEW:

The need for mental health and substance use disorder care continues to increase at a steady rate, often outpacing the availability of services, impeding access to care. Providers are challenged to implement programming that meets unique, complex community needs; this is made even more difficult by the fragmented delivery environment. This program features emerging models of care for everyday clinical practice across the continuum of care.

OBJECTIVES:

1. Discuss how a centralized model for screening and stabilization of patients in need of psychiatric care can improve quality and lower costs
2. Discuss how early adverse childhood experiences influences the mental and physical health of individuals across the continuum of care
3. Review the components of a cross-provider collaborative to improve care for pediatric patients
4. Learn how psychiatry and social work co-located within a certified home health agency can provide in-home assessment of homebound elders with mental disorders, engage them in mental health treatment and help maintain them safely in the community
5. Identify elements of a bedside, nurse-driven protocol for management of alcohol/polysubstance abuse withdrawal that are transferrable to the local level of care
6. Understand the complexities of gender identity in order to enhance patient care and improve outcomes.
