About the Speakers:

Assemblywoman Nancy Pinkin (D-Edison) runs her own healthcare and association management consulting firm, Pinkin Associates, Inc., and has an extensive background in healthcare administration with an expertise in ambulatory care and medical practice management. She is also the executive director of the Middlesex and Mercer County Medical Societies.

Assemblywoman Pinkin served on the East Brunswick Township Council from 2005 - 2014, including a two-year term as council president. She also served three years on the East Brunswick Planning Board.

Pinkin received an associates degree from Middlesex County College in Applied Science, a Bachelor of Science degree from Rutgers University, and holds a Master of Public Administration with a specialization in health administration from New York University. She completed a postgraduate fellowship in health policy and research at UMDNJ where she also served as health policy advisor to then-State Senator Jack Sinagra.

Assemblyman Tim Eustace (D-Paramus) is a chiropractor and Democratic Party politician from Maywood, N. J., representing his district since 2012. Before joining the Legislature, Eustace served several terms on the Maywood Borough Council, and he served as mayor from 2008-2012.

In 1978, he earned a Bachelor of Science degree in psychology from Ramapo College in Mahwah, N. J. Attending Pennsylvania College of Chiropractic, Eustace earned a doctorate in 1985 and became a licensed chiropractor.

Senator Gerald Cardinale received a B.S. degree from St. John's University (Chemistry) in 1955 and was awarded a D.D.S. from the New York University College of Dentistry in 1959. Gerald Cardinale is a dentist by profession and an American Republican Party politician, who has served in the New Jersey State Senate since 1982, where he represents the 39th Legislative District.

Assemblyman Herbert Conaway (D-Delran) - graduated with a B.A. from Princeton University in Politics, received an M.D. degree from Jefferson Medical College at Thomas Jefferson University and was awarded a J.D. from Rutgers School of Law—Newark. He is the only member of the legislature to hold both a medical degree and law degree."
