OVERVIEW:

Since April 2016, many New Jersey hospitals have been required to participate in the Centers for Medicare and Medicaid Services (CMS) mandatory comprehensive joint replacement (CJR) bundling program. As a result of this first mandatory bundling program in the nation, relationships between hospitals, physicians and post-acute providers, such as skilled nursing facilities and home health agencies, have continued to be transformed. NJHA and LeadingAge NJ are hosting this program now that hospitals are in the process of evaluating early results that will determine their performance vis-à-vis financial reconciliation. This program will begin with a look at the national landscape provided by Kelly C. Price, Vice President and Chief of Healthcare Data Analytics, at DataGen, followed by a panel of New Jersey hospitals and post-acute providers that have been engaged in the model who will discuss the operational, data analytic, systems, clinical, network development and other initiatives behind their participation in CJR as well as their plans for moving into year two of the model.

OBJECTIVE:

- Understand the CJR model's key characteristics and implementation nationally.
- Learn what the early data from CJR has shown in different regions of the nation
- Understand how CJR has altered hospitals' internal operations and relationships with orthopedic surgeons
- Identify how CJR has led to new or different relationships between hospitals, post-acute providers and physicians
- Determine how to adjust operations going forward to have the best possible outcomes for patients and success for the provider community in the model.
