OVERVIEW:

On Oct. 4, 2016, the Centers for Medicare and Medicaid Services finalized updated requirements of participation for long term care facilities. This is the first major revision to the federal rules since the early 1990s. This program will be offered as **13** one-hour sessions via webinar beginning June 5. Each session will be offered twice, with the exception of the introductory session; sessions will also be recorded and available for registered participants only. The webinars will focus on the provisions that require compliance under phases 1 and 2. Key action steps required will be discussed.

OBJECTIVES:

- To understand the requirements for compliance by Nov. 28, 2016.
- To plan for the requirements that take effect by Nov. 28, 2017.
- To identify areas for facility policy and procedure development or revision.
- To learn CMS' expectations with respect to compliance.
