OVERVIEW:

The mission of the New Jersey Sepsis Learning-Action collaborative and this face-to-face program is to spread evidence-based sepsis interventions throughout the acute and post-acute care settings. In this third year of the collaborative, hospitals face challenges related to managing sepsis in vulnerable patient populations, preventing readmissions related to sepsis and engaging patients and their families in sepsis quality improvement efforts aimed at early recognition and rapid treatment of sepsis.
