## Program Overview:

New Jersey Hospital Improvement Innovation Network (NJHIIN) is hosting a learning-action collaborative aimed at reducing Medicaid Readmissions. Reducing all-payer readmissions has been a long-standing focus of the NJHIIN work, and now with new Medicaid readmission non-payment policies, organizations need to be prepared to implement practices aimed at preventing readmissions in this patient population.

To improve processes aimed at reducing readmissions, Dr. Amy Boutwell, author of the [ASPIRE](#) readmission reduction model, will lead New Jersey organizations through the steps of this framework using discussion, coaching and workshop style learning.

## Objectives:

1. Articulate your overall readmission reduction goal and strategy
2. Specify your Medicaid readmission reduction goal and strategy
3. Develop 3 detailed implementation action plans

## Learner Outcome:

The learner will be able to state their organizations Medicaid readmission goal and identify 2 action strategies to achieve the goal.

\*Successful completion of the course is defined as in-person attendance for 95% of the didactic learning session, development of 3 detailed implementation action plans and a completed course evaluation.

## Target Audience:

Readmission reduction teams – MDs, RNs, pharmacists, social workers, case managers, quality directors and at least one “Medicaid-relevant” non-hospital partner (behavioral health, peer support, community health worker, community based social worker)

**Format:**

This is a working session. Attendees will receive direct advisement on developing practical, effective strategies to reduce Medicaid readmissions, informed by national expertise and by the ideas and efforts of collaborating NJHA HIIN teams. Attendees should be those who have the ability to develop and implement plans to reduce Medicaid readmissions.

**Preparation:**

The more you invest in the pre-work, the more you will benefit from the working session. Dr. Boutwell will assume you have attended first webinar, pre-work office hours, and have reviewed the ASPIRE Guide. Bring results of your pre-work, or questions about the work if you are unable to do it. Dr. Boutwell recommends that you bring a Medicaid-relevant partner who is willing to work to reduce readmissions (clinic, care manager, behavioral health, social work; see ASIPRE Chapter 5).
