OVERVIEW:

2017 was a devastating year with natural disasters such as catastrophic floods, wildfires and earthquakes affecting millions across the globe. 2017 also endured the deadliest mass shooting in modern history.

Come listen to leading experts discuss the impact and lessons learned from the hurricanes in Texas and Florida and the mass shooting in Las Vegas.

Hurricane Harvey – The strongest Gulf hurricane to hit the United States since Hurricane Wilma in 2005 and the fiercest to strike southeast Texas since 1961.

Hurricane Irma – The most intense Atlantic storm to hit the United States since Katrina in 2005, leading to scores of deaths, including 14 at a nursing home in Hollywood, Florida.

Las Vegas Massacre – On October 1, 2017, 22,000 people at a country music festival were fired upon by a lone gunman at the Mandalay Bay hotel on the Las Vegas strip. The attack, which left 58 people dead and more than 500 injured, marked the deadliest mass shooting in modern U.S. history.
