### OVERVIEW:

In late 2017, CMS released preliminary results for the Comprehensive Joint Replacement (CJR) mandatory bundling program. New Jersey hospitals involved in CJR had varying experiences related to quality metrics and reconciliation payments. Early in 2018, CMS decided that New Jersey's hospitals must continue in the mandatory CJR program, even though other parts of the country are now considered voluntary for purposes of CJR. This seminar will explore the reasons for CMS' decision to mandate CJR in New Jersey, the experiences of several CJR hospitals to-date, and what to expect going forward. In addition, experts from DataGen will examine the Bundled Payment for Care Improvement (BPCI) Advanced rollout that CMS announced in January. This will include a look at the likely participants in New Jersey, impact on hospitals and physicians of BPCI Advanced being an advanced alternative payment model (APM) and the need for post-acute providers to remain engaged and active in this program.

- Learn the key elements of BPCI Advanced.
- Understand how post-acute care fits into BPCI Advanced.
