OVERVIEW:

The mission of the New Jersey Sepsis Action collaborative and this face to face program is to spread evidence-based sepsis interventions throughout the acute and post-acute care settings. In this fourth year of the collaborative, hospitals face challenges related to managing sepsis in pediatric patient populations, preventing readmissions related to sepsis and engaging patients and their families in learning about life after sepsis. This program will focus on dealing with those challenges and building on past successes to sustain the improvement efforts aimed at early recognition and rapid treatment of sepsis.

Important: All participants must prepare and present a sepsis storyboard during the conference poster presentations sessions. The topic of the storyboard is "What is your team doing to improve sepsis care across the continuum?" Address a problem or observation that led to an innovative solution, development of a tool or change in process for a specific patient population across the continuum (pediatric, maternal, elderly, pneumonia, etc.)

Storyboards can be displayed as no more than six PowerPoint slides or a poster. The day of the learning session, teams should bring their printed slides/poster to NJHA.

When you arrive the morning of the learning session, you will receive information indicating which time and table location on which your storyboard should be posted. Teams will be assigned to present during one of two 45-minute storyboard sessions. These sessions will be held in a gallery format with teams rotating through and viewing individual storyboards.

Once registered, you will receive the storyboard template that you may use to guide your presentation.

Objective:

- Discuss the current state of sepsis quality improvement activities in New Jersey and nationally
- Understand how to implement a pediatric sepsis screening and treatment program
- Describe the functions and responsibility of the sepsis coordinator role
- Discuss relevant resources to engage patients and families in understanding the impact of sepsis and the expectation of life after sepsis.

LEARNER OUTCOME:

After successfully completing the course, the learner will identify one innovative strategy to improve sepsis identification and management, transferrable to their organization.

Successful completion of the course is defined as in-person attendance for 95% of the didactic learning session and a completed course evaluation
