The 2019 ICD-10-CM and PCS updates are effective with discharges on and after October 1, 2018. Will you be ready? This comprehensive webinar series will familiarize you with the changes to the diagnosis (CM) and procedure (PCS) code sets that are imperative to know, understand, and implement within your facility.

Session I: ICD-10-CM Updates for 2019 webinar will explain the ICD-10-CM updates, including new guidelines, codes, and new CC/MCCs for FY 2019 that will be implemented on Oct. 1, 2018. The ICD-10-CM code set for 2019 includes 279 additions, 51 deletions, and 143 revised codes.

Topics covered include: changes to coding subsequent myocardial infarctions, coding for healthcare encounters in hurricane aftermath, factitious disorders, coding for social determinants of health, sepsis due to a postprocedural infection, hypertension with other heart conditions, drug use during pregnancy, Glasgow coma scale, coding burns of multiple sites, underdosing, suspected cases of forced exploitation, and BMI coding.

Session II: ICD-10-PCS Updates for 2019 webinar will explain the information on the ICD-10- PCS updates for FY 2019 that all hospital inpatient coding professionals need to know and implement effective Oct. 1, 2018. The ICD-10-PCS code set for 2019 includes PCS guideline changes and 392 new codes; eight revision titles; and 216 deleted codes.

Topics covered include: changes to guidelines regarding transfer procedures using multiple tissue layers, revisions to guidelines regarding "and" in a code description, correct coding of devices, changes to bypass tables, dilation tables, extirpation tables, new control tables, destruction table changes, new extraction tables, additions to fusion tables, revisions to removal and replacement tables, additional body parts now listed for transplantation, brand new transfer tables, revisions to the maternal delivery table, changes to introductions tables used for injections, and more!

Webinar participants will:

- Learn to recognize code changes in ICD-10-CM and PCS for FY 2019
- Gain an understanding of how to implement the ICD-10-CM and PCS changes in your facility
- Recognize how to reduce denials by reporting the 2019 ICD-10-CM and PCS codes accurately and timely by the Oct. 1st effective date
