#### **OVERVIEW:**

Sexual assault and abuse of elders living in nursing homes and other senior living environments is a significant issue that often goes unreported. Residents are more physically and cognitively frail than ever before and are increasingly vulnerable to this type of abuse. Residents, families and staff often do not know what to do if they suspect sexual abuse has occurred. This program will focus on the prevention and detection of sexual abuse, the many ethical concerns related to sexual abuse, best practices in training and advocacy on behalf of residents, liability and regulatory concerns and strategies for risk management.

## **OBJECTIVES:**

- To dispel myths and assumptions about sexual abuse of elders
- To learn how to detect signs and symptoms of sexual assault
- To understand the elements of proper investigation and reporting requirements
- To learn the statutory and regulatory aspects related to sexual abuse
- To identify key ethical issues involved in sexual abuse and how to address them
- To adapt a staff training model for use in your organization
- To learn how to develop risk management strategies focused on sexual abuse

#### **LEARNER OUTCOME:**

After successfully completing the course, the learner will know how to detect signs and symptoms of sexual assault related to the elderly living in senior living environments and will be able to identify three risk management strategies to mitigate sexual abuse in the elderly, transferrable to their organization.
