OVERVIEW:

NJHA and LeadingAge NJ continue to pursue efforts to foster communication and collaboration surrounding the ever-changing Medicaid Managed Care environment by offering the fifth annual Medicaid Managed Care Provider Update.

Attendees across the continuum of care will learn about recent policy and operations updates from the Department of Health Services. In addition, each of the Medicaid Managed Care Organizations will offer presentations on their Medicaid managed care operations for acute care, MLTSS and the Medicaid expansion population, including those covered under the alternative benefit plan. Additionally, this year representatives from New Jersey's Programs of All-Inclusive Care for the Elderly (PACE) will participate and provide an overview of PACE enrollment and operations.

Topics will include eligibility determinations, enrollment, care management, quality measurements, claims process and payments.

- To learn about the Department of Human Services' ongoing implementation of the behavioral health carve-in, MLTSS and updates to programs, policies and the comprehensive Medicaid waiver.
