OVERVIEW:

Approximately 1.1 million persons in the United States are currently living with HIV, and more than 700,000 persons have died of AIDS since the first cases were reported in 1981, according to a JAMA Network article. The estimated prevalence of HIV infection among persons 13 years and older in the United States is 0.4 percent (0.7 percent in males and 0.2 percent in females), and data from the Centers for Disease Control and Prevention 2017 HIV Surveillance Report show a significant increase in HIV diagnoses starting at age 15 (compared with ages 13-14 years). The annual number of new cases of HIV infection diagnosed in the United States has decreased slightly in recent years, from about 41,200 new cases in 2012 to 38,300 in 2017, according to a JAMA Network article. Approximately 15 percent of persons living with HIV are unaware of their infection. It is estimated that persons unaware of their HIV status are responsible for 40 percent of transmission of HIV in the United States.

Columbia University HIV Behavioral Health Training provided free training on the latest developments in behavioral health aspects of the HIV epidemic. We train care providers throughout New York, New Jersey, Puerto Rico and the U.S. Virgin Islands. Faculty are experienced educators, practitioners, administrators and researchers in HIV and behavioral health. The program is funded by the Health Resources and Services Agency, Columbia University and New York State Psychiatric Institute.

OBJECTIVES:

This program is intended to have experts work with individual healthcare providers, team and clinical sites in New Jersey to provide targeted, multi-disciplinary education and training programs and capacity building assistance to improve care along the HIV care continuum.

LEARNER OUTCOME:

After successfully completing the course, the learner will identify two strategies to improve outcomes for care along the HIV care continuum.

Successful completion of the course is defined as in-person attendance for 95 percent of the didactic learning session and a complete course evaluation.

TARGET AUDIENCE:

Physicians, advance practice nurses, registered nurses, social workers, case managers, post-acute care, home health, public health nurses, care coordinators and discharge planners
