Diseases of the: Blood and Blood Forming Organs, Ear and Mastoid Process; Circulatory System; Skin and Subcutaneous Tissue; Genitourinary System; Congenital Malformations; Symptoms, Signs, and Abnormal Findings; Injuries, Poisoning, and Certain Consequences of External Causes; External Cause of Morbidity; Factors Influencing Health Status and Contact with Health Service.
