## **OVERVIEW:**

The New Jersey Hospital Improvement and Innovation Network (NJHIIN) is committed to working with its members to improve antimicrobial stewardship programs (ASP) and associated patient outcomes.

Improving the use of antimicrobials in healthcare to protect patients and reduce the threat of antimicrobial resistance is a national priority. Antimicrobial stewardship refers to a set of commitments and actions designed to “optimize the treatment of infections while reducing the adverse events associated with antimicrobial use.”

The mission of the NJHIIN Antimicrobial Stewardship Learning Action Collaborative is to promote the use of the appropriate agent, dose, duration, and route of administration of antimicrobial agents both in the acute care setting and in the post-acute care setting in order to improve quality of patient care and patient safety while reducing excessive costs attributable to inappropriate antimicrobial use.

## **Instructions for storyboard presentations**

All conference participants are asked to create and present a storyboard outlining their organizations “Top Accomplishments” thus far in implementing their 2019 antimicrobial stewardship programs. There should be one storyboard per organization. Topics for the storyboard should include:

- Most significant patient outcomes related antimicrobial stewardship
- Successful implementation of a new antimicrobial stewardship process

The day of conference, participants should bring their slides/poster attached to a trifold board to NJHA. When you arrive the morning of the learning session, you will receive information indicating which table location your storyboard will be posted on. The session will be held in a gallery format with participants walking through and viewing individual storyboards.
