OVERVIEW:

Sexual violence against seniors in all settings is a tragedy. Unfortunately, it is on the rise. This seminar is designed for healthcare and senior living staff in nursing, social work, recreation, rehabilitation, dining and administration to understand the facts of sexual violence, the rights of seniors, behaviors that are considered sexual violence, the impact on survivors, how to support survivors, how to report incidents and creating a culture of safety that does not tolerate any form of sexual violence. Our faculty include experts in the field of sexual violence, healthcare regulation and law enforcement.

- To understand the facts – myths vs. reality – of sexual violence against seniors in healthcare and other settings
- To learn the behaviors – subtle and overt – that are considered sexual violence under the law
