

JHA's *Payer Information Resource System (PIRS)* is the definitive source for New Jersey HMO information. The report has recently been redesigned around the goals of expediency and practicality, enabling users to quickly locate the most pertinent managed care data while simultaneously allowing NJHA to turn the report around in a shorter time frame.

The PIRS includes year-to-date performance summaries for each HMO in the areas of finance, utilization and enrollment, as well as annual listings of the contract status between each plan and individual acute care hospitals. The report also contains valuable enrollment data presented in two ways: one-page county-level exhibits showing enrollment by HMO plan; and one-page HMO snapshots with enrollment by county.

The Payer Information Resource System is generated semi-annually (at year-to-date periods ending June 30 and December 31) and is distrib-

uted solely via e-mail. The report must be viewed using the Adobe Reader software (available as a free download at http://www.adobe.com/products/reader/).
